Maharashtra has issued the directive for single application for MVAT CST & PT ACT (both PT RC and PT EC). The complete process for application under Maharashtra Value Added Tax Act, Central Sales Tax Act and Profession Tax Act are attached for reference.

### **MVAT CST & PT Registration Process in Maharashtra**

Manufacturers availing exemption on the basis of value of their annual clearance, manufacturer of processed yarn, unprocessed fabrics falling under chapters 50 through 55,58 or 60 of the Central Excise Tariff or manufacturers of readymade garments.
